Admission Requirements:

Work plan:

The candidate will be integrated into a research team where they are expected to contribute to the implementation and testing of radio communication protocols based on the 3GPP 5G NR standard.

Applicable legislation and regulation:

The award of the research grant will be formalized through the signing of a grant contract between the *Instituto Politécnico de Castelo Branco* (IPCB) and the grant holder, in accordance with the Statute of the Scientific Research Fellow, established by Law No. 40/2004 of August 18, as amended, and with the Regulation "*Regulamento de Bolsas de Investigação Científica do Instituto Politécnico de Castelo Branco*".

Place of work:

The research will be conducted at the *Instituto Politécnico de Castelo Branco*, specifically within the *Escola Superior de Tecnologia*, under the scientific supervision of Professor Paulo Jorge Coelho Marques.

Scholarship duration:

The research grant is expected to start on December 10, 2025, with a duration of 25 months.

The grant amount is €1,040.98, in accordance with the table set out in the Regulation of Research Grants of the Foundation for Science and Technology (FCT, I.P.). The grant is paid monthly, via bank transfer. This amount may be supplemented by Voluntary Social Security contributions.

- Curriculum assessment based on the submitted documentation (weight: 60%);
- Candidate interview (weight: 40%).
